

REGULATIONS FOR THE PARTICIPANTS OF "PYSZNA POLSKA 2017" FAIR

Gastronomy and Hotel Fair of Magda Gessler

Edition title: **"Navigation on the culinary and hotel map of Poland"**

CENTENNIAL HALL - Wrocław Exhibition Centre

1. The provisions of this Regulations are in effect for the Participants of the Fair called PYSZNA POLSKA 2017 International Fair, organised by the MB Business Service Sp. z o.o. Company ul. Nowogrodzka 31, 02-511 Warsaw, hereinafter referred to as the ORGANISER.
2. Duration time:
 - 2 June 2017, in hours between: 10:00 am - 21:00 pm,
 - 3 June 2017, in hours between: 10:00 am - 21:00 pm,
 - 4 June 2017, in hours between: 10:00 am - 21:00 pm.
3. Entrance to the PYSZNA POLSKA International Fair is paid and can be done by:
 - a) registering in the electronic system available at the organiser's webpage www.wroctargi.pl - in the FOR VISITORS tab. The card payments and e-transfers are handled by the "Dotpay" System,
 - b) passes or tickets can be purchased at selling points outside the Fair entrance.
4. Entrance passes to the Fair can be collected in the following manner:
 - a) User who registered in the system may print out the pass by logging in on the webpage www.wroctargi.pl,
 - b) User who purchased the passes or tickets on the day of the Fair may collect them at the selling points outside the Fair entrance.
5. Users who registered electronically at the Organiser's webpage will receive a discount in the amount specified in the price list found at the Organiser's webpage.
6. Participation submission is considered as completed on the day the above mentioned conditions are met.
7. The Organiser may refuse to sell the entrance tickets when they out of stock or the number of people gathered at the Fair premises becomes dangerous to the Participants.
8. In case of cancelling the participation, the registration fee is not refundable.
9. By purchasing and using (presenting at the entrance) the entrance pass, band or ticket for the PYSZNA POLSKA 2017 International Fair, the Participant declares that they know the Regulations and obligate to follow it.
10. The participation in the Fair is available only during its opening hours for the Visitors.
11. An adult person who brings children to the Fair obligates to take care and supervision over such children and is legally responsible for them based on article 427 of the Civil Code (supposed fault in supervision).

12. In case a child is lost, one should report to the Organiser's representative by the main stage or at the reception.
13. In case of any accident or danger to the safety of the Fair participants, one should immediately report to the Organiser's representative or the nearest member of Security Personnel (security guard).
14. The Visitors of the Fair are prohibited from bringing and possessing on the Fair premises weapons or other dangerous objects, explosives, pyrotechnic articles, materials forming fire hazard, alcohol drinks, narcotic drugs or psychotropic substances, but also substances that are volatile, toxic, corrosive or reeking.
15. Bringing animals to the Fair premises is prohibited.
16. At the Fair an absolute prohibition concerns:
 - a) smoking tobacco and other products containing harmful substances,
 - b) consuming alcohol outside places designated for this purpose,
 - c) taking narcotic or psychotropic drugs,
 - d) consuming meals, except for the places designed for this purpose,
 - e) conducting any fundraising, acquisition, advertising, promotion and propaganda activities, without the prior written consent of the Organiser, using open fire.
17. The Visitors may move around the Fair premises only in the zones assigned to that and specially marked.
18. It is prohibited, without the prior written consent of the Organiser, to record the Fair or its fragments by means of devices recording sound or vision.
19. The Organiser, its representatives or members of the Security Personnel (security guards) may not allow to enter to the Fair premises or remove from the Fair premises a person who is under influence of alcohol, narcotic drugs or psychotropic substances, as well as a person who violate the Regulations or generally applicable legal standards, or creating a threat for order or safety of other visitors.
20. The Organiser may record the Fair, and especially the behaviour of its Visitors, by means of devices recording sound or vision and present the materials gathered in such a manner to the appropriate authorities in the situations provided for under the law.
21. The Organiser is not a party in any legal relationships concluded during the Fair between the Visitors and the Exhibitors or any other Fair participants and will not be held liable for that reason.
22. The Organiser is not responsible for the form or content of advertising and promotional materials that are used by the Exhibitors during the Fair.
23. The Participants are obligated to exercise control over their own movable property brought to the Fair premises. Especially, the Organiser is not responsible for loss, theft, damage or devastation of the Participant's movable property.
24. The Organiser is not responsible for any damages done to the Visitors by other Fair participants.
25. The Organiser reserves the right to produce video films, photographs and audio recordings or publications in any other form of the materials related to the Fair, which may contain the image of the Participant as well as recordings of the Fair course. By applying for

participation in the Fair, the Participant agrees to use their image on all the forms of exploitation, without any additional remuneration, and moreover declares that they will not make any claims related to the indicated people/companies. The above consent cannot be withdrawn during or after the Fair. All the copyrights to the materials related to the Fair belong to the Organiser, and the exclusive right to use them (especially the right to distribute them on any medium, on the Internet, copying, etc.) belongs to the Organiser.

26. All the rights to the materials presented during the Fair are fully protected by the law, provided by appropriate provisions of the Polish law, including the provisions of the Copyright and Neighbouring Rights Act from 4 February 2001 and the Suppression of Unfair Competition Act from 16 April 1993.

The usage of the materials is allowed only in accordance with the conditions and in the scope that corresponds to own personal use and allowed public use. The terms and scope of such own personal uses and allowed public use is determined by the Copyright and Neighbouring Rights Act. Copying, borrowing and paid sharing - in part or as a whole - of the delivered materials to other entities is prohibited. The Participant is not granted with any copyrights as well as any intellectual property rights that belong to the Organiser.

27. The Organiser reserves the right to alter the Regulations, indicating that the binding content of the Regulations for the Participant and the Organiser is the content of the Regulations in force on the date of purchasing the pass or ticket by the Participant.
